

# Public Meeting on Proposed Sale of St. Joseph Regional Medical Center

## Monday, December 12, 2016 ~ 5:30 P.M. PST

Attorney General Lawrence Wasden is reviewing the proposed sale of **St. Joseph Regional Medical Center**, a Lewiston, Idaho, nonprofit hospital, to **St. Joseph Hospital, LLC**, a subsidiary of **RegionalCare Hospital Partners Holdings, Inc., d/b/a RCCH HealthCare Partners**, a for-profit corporation. **Ascension Health, Inc.**, a Missouri nonprofit corporation, currently owns St. Joseph Regional Medical Center, which primarily serves patients from Nez Perce County, Idaho, and Clarkston, Washington. The Attorney General reviews proposed nonprofit hospital sales transactions pursuant to his authority under title 48, chapter 15, Idaho Code.
