Lawyer Referral Service-Idaho State Bar- The Lawyer Referral Service (LRS) is operated as a public service of the Idaho State Bar. All LRS attorneys are members in good standing with the Idaho State Bar with no pending public disciplinary complaints and carry professional liability insurance. LRS attorneys have agreed to provide their clients with an initial up to a half-hour consultation at no fee. The fee for a referral is \$35 unless the cases are personal injury, medical malpractice, or workers' compensation which receive a free referral. After the initial consultation, any further fees are to be negotiated between the lawyer and the client. Not all Idaho State Bar attorneys are members of the LRS service.

Catholic Charities of Idaho- Immigration Legal Services- Catholic Charities of Idaho is a Department of Justice (DOJ) accredited non-profit organization in Idaho, providing low-cost immigration legal services to individuals eligible to receive immigration benefits. CCI provides legal consultations and assistance regarding most immigration matters including citizenship, family petitions, applications for victims of certain qualifying crimes such as domestic violence and other applications. Idaho State Law library- The primary mission of the Idaho State Law Library is to assist the Idaho Supreme Court in carrying out its responsibility for the administration of justice in the state and to help increase the public's access to and understanding of the court system. This mission is accomplished by acquiring and maintaining appropriate legal resources; promulgating policies and rules for the use of these materials; and regularly reviewing the programs, policies and services of the library to ensure that they meet the current and future needs of the Court and other library patrons.
